Plan Descriptions

A description of how parents, teachers, and school staff were involved in the development of the plan.

Seeley Union School District (SUSD) established an Expanded Learning Opportunities Grant Plan committee composed of administration, certificated staff, classified staff, and parent community. The purpose for the committee was to look at the needs of all our students including Students with Disabilities, English Learners, Homeless, Foster Youth, and Socioeconomically Disadvantaged. In addition to student needs, the committee was tasked with reviewing the needs of staff and programs to strategize a comprehensive plan to provide the best supplemental instruction and support to accelerate student learning. The needs identified included academic learning loss and the need for social emotional supports. Additionally, child nutrition will be essential in ensuring our student population is receiving adequate meals.

A description of how students will be identified and the needs of students will be assessed.

SUSD will utilize input from teachers, school counselor, and parents to identify students who have academic learning loss and or social emotional needs. Once identified, students will participate in a Summer Learning Program where students will be administered a diagnostic assessment via iReady. iReady will create a path for students to continue to work on areas of need in combination with the iReady Common Core Supplemental materials in both reading and math instruction. The District will progress monitor student learning and continue to analyze data to ensure students are showing academic growth and identify and modify areas of support. During the 2021-2022 school year, the District will utilize Renaissance as a tool for our MTSS model to provide students scaffolds, intervention, and progress monitoring. Extended Day Tutoring will be in place for students who need additional support. The school counselors will play a key role in identifying students with social emotional needs and will create a program for teachers to implement throughout the Summer Learning Program as well as creating small group intervention pull-out for the 2021-2022 Extended Day Tutoring. The District will also base student needs on attendance and

engagement to transition students from Distance Learning to In-Person Learning. Implementing academic expectations are crucial in ensuring all students are taking an active role in their learning provided through Expanded Learning Opportunities.

SUSD initiated the coordination of the Summer Learning Program via a Parent Forum. Once students are identified, parents will receive a written informational invitation for student participation. Parents will receive a Diagnostic report and communication meetings will take place virtually, via phone call, and via email. The District will continue to utilize our communication platform Class Dojo, instructional platform Google Classroom, and virtual communication platform Zoom as tools to guide our communication. As the 2021-2022 school year begins, students will all begin the school year with a diagnostic assessment that is part of our District progress monitoring plan. This initial assessment along with teacher input, will determine MTSS groups and Extended Day Tutoring student groups. In addition, SUSD will meet the needs of the parent community by creating a Community Learning Hub where parents will be provided with technology in order to provide parent support with academic and social emotional needs of students.

A description of the LEA's plan to provide supplemental instruction and support.

SUSD will provide supplemental instruction support through the Summer Learning Program and Extended Day Tutoring to all students identified for accelerated learning, attendance and engagement needs, and those in need of social emotional supports. The District will utilize Renaissance and Common Core Reading and Math Instruction to create small group interventions based on the academic needs of students using the MTSS model. The use of frontloading strategies, academic language frames, and graphic organizers will be aligned with grade-levels. The District will continue to provide a safe environment for all students and staff.

The Expanded Learning Opportunities Committee collaborated in the development of this plan and members also participated in sessions for the Federal Elementary and Secondary School Emergency Relief expenditures. All funding is being allocated to support all students in accelerating academic achievement, social emotional needs, providing a safe and orderly environment, and providing greater student engagement in academics and extracurricular activities. Expanded Learning Opportunities Grant Plan Instructions: Introduction

The Expanded Learning Opportunities Grant Plan must be completed by school districts, county offices of education, or charter schools, collectively referred to as Local Educational Agencies (LEAs), that receive Expanded Learning Opportunities (ELO) Grant funds under California *Education Code (EC)* Section 43521(b). The plan must be adopted by the local governing board or body of the LEA at a public meeting on or before June 1, 2021, and must be submitted to the county office of education, the California Department of Education, or the chartering authority within five days of adoption, as applicable. The plan must be updated to include the actual expenditures by December 1, 2022.

Instructions: Plan Requirements

An LEA receiving ELO Grant funds under *EC* Section 43521(b) is required to implement a learning recovery program that, at a minimum, provides supplemental instruction, support for social and emotional well-being, and, to the maximum extent permissible under the guidelines of the United States Department of Agriculture, meals and snacks to, at a minimum, students who are included in one or more of the following groups:

- low-income,
- English learners,
- foster youth,
- homeless students,
- students with disabilities,
- students at risk of abuse, neglect, or exploitation,
- disengaged students, and
- students who are below grade level, including, but not limited to, those who did not enroll in kindergarten in the 2020–21 school year, credit-deficient students, high school students at risk of not graduating, and other students identified by certificated staff.

For purposes of this requirement

- “Supplemental instruction” means the instructional programs provided in addition to and complementary to the LEAs regular instructional programs, including services provided in accordance with an individualized education program (IEP).
- “Support” means interventions provided as a supplement to those regularly provided by the LEA, including services provided in accordance with an IEP, that are designed to meet students’ needs for behavioral, social, emotional, and other integrated student supports, in order to enable students to engage in, and benefit from, the supplemental instruction being provided.
- “Students at risk of abuse, neglect, or exploitation” means students who are identified as being at risk of abuse, neglect, or exploitation in a written referral from a legal, medical, or social service agency, or emergency shelter.

EC Section 43522(b) identifies the seven supplemental instruction and support strategies listed below as the strategies that may be supported with ELO Grant funds and requires the LEA to use the funding only for any of these purposes. LEAs are not required to implement each supplemental instruction and support strategy; rather LEAs are to work collaboratively with their community partners to identify the

supplemental instruction and support strategies that will be implemented. LEAs are encouraged to engage, plan, and collaborate on program operation with community partners and expanded learning programs, and to leverage existing behavioral health partnerships and Medi-Cal billing options in the design and implementation of the supplemental instruction and support strategies being provided (*EC* Section 43522[h]).

The seven supplemental instruction and support strategies are:

1. Extending instructional learning time in addition to what is required for the school year by increasing the number of instructional days or minutes provided during the school year, providing summer school or intersessional instructional programs, or taking any other action that increases the amount of instructional time or services provided to students based on their learning needs.
2. Accelerating progress to close learning gaps through the implementation, expansion, or enhancement of learning supports including, but not limited to, any of the following:
 - a. Tutoring or other one-on-one or small group learning supports provided by certificated or classified staff.
 - b. Learning recovery programs and materials designed to accelerate student academic proficiency or English language proficiency, or both.
 - c. Educator training, for both certificated and classified staff, in accelerated learning strategies and effectively addressing learning gaps, including training in facilitating quality and engaging learning opportunities for all students.
3. Integrated student supports to address other barriers to learning, such as the provision of health, counseling, or mental health services, access to school meal programs, before and after school programs, or programs to address student trauma and social-emotional learning, or referrals for support for family or student needs.
4. Community learning hubs that provide students with access to technology, high-speed internet, and other academic supports.
5. Supports for credit deficient students to complete graduation or grade promotion requirements and to increase or improve students' college eligibility.
6. Additional academic services for students, such as diagnostic, progress monitoring, and benchmark assessments of student learning.
7. Training for school staff on strategies, including trauma-informed practices, to engage students and families in addressing students' social-emotional health needs and academic needs.

As a reminder, *EC* Section 43522(g) requires that all services delivered to students with disabilities be delivered in accordance with an applicable IEP.

Fiscal Requirements

The following fiscal requirements are requirements of the ELO grant, but they are not addressed in this plan. Adherence to these requirements will be monitored through the annual audit process.

- The LEA must use at least 85 percent (85%) of its apportionment for expenditures related to providing in-person services in any of the seven purposes described above.
- The LEA must use at least 10 percent (10%) of the funding that is received based on LCFF entitlement to hire paraprofessionals to provide supplemental instruction and support through the duration of this program, with a priority for full-time paraprofessionals. The supplemental instruction and support provided by the paraprofessionals must be prioritized for English learners and students with disabilities. Funds expended to hire paraprofessionals count towards the LEAs requirement to spend at least 85% of its apportionment to provide in-person services.

- An LEA may use up to 15 percent (15%) of its apportionment to increase or improve services for students participating in distance learning or to support activities intended to prepare the LEA for in-person instruction, before in-person instructional services are offered.
